# Black Hills Community Needs Assessment 2011

## Executive Summary

A consortium of 17 organizations in the Black Hills commissioned the South Dakota Public Policy Institute, a project of the Chiesman Center for Democracy, to conduct a Community Needs Assessment study in the Black Hills area. Areas included in this assessment are Butte County, Lawrence County, Meade County, Fall River County, Custer County, and Pennington County. This study is a followup to a study commissioned by the United Way of the Black Hills in 2001 that included Rapid City, the City of Sturgis, and Spearfish and the 2006 study that included Pennington County, Meade County, Lawrence County, and Butte County.

Many of the topics covered in this study were similar to those found in the **2001 Community Needs Assessment Study** and the **2006 Black Hills Community Needs Assessment Study**. The 2011 study is similar to the 2006 study but with additional topical areas.

In this study the assessment is divided into eight issue areas. They include:

- Employment
- Education
- Crime & Safety
- Child & Adolescents
- Housing
- Health (Physical & Mental)
- Art & Culture
- General

### Jobs Are Perceived as the Area's Greatest Need

- Ninety-one percent (91.3%) of respondents checked "Lack of good paying jobs" as a problem in their community. This was the highest priority in 2001 and 2006.
- Lack of job opportunities was also seen as a community problem for 76.4% of the respondents and unemployment / underemployment a problem for 75.7%. These were also top concerns in 2006.
- Interestingly, while jobs are seen as the largest community issue, they are only seen as a household issue by 4.4% of respondents in 2011 and 6.2% in 2006.

### Addictions Are Seen as the Second Largest Issue Facing Communities

- Eighty-two percent (81.7%) of respondents cited alcohol use and abuse as a concern, while 80.7% indicated that drug use and abuse as an issue. Both of these areas were in the top ten community concerns in 2001 and 2006.
- Drug use and abuse (25.0%) and alcohol use and abuse (21.6%) was seen as a problem in the schools. While in the schools it was one of the top ten concerns, it was not true for the home.

- Two-thirds of the respondents (65.1%) indicated that prescription drug use and abuse was a problem within their community.
- Substance use was in the top ten concerns for schools in 2001 and 2006. About 39.2% of the respondents rated the current drug and alcohol prevention services unsatisfactory. If these programs exist in the community they are not addressing the use and abuse prevention and treatment services adequately.
- Sixty-three percent (62.7%) of the respondents indicated that gambling was a concern within their community. Forty percent (40.0%) rated the gambling treatment services unsatisfactory.

### **Medical and Mental Health are Seen as Major Needs For The Community & School**

- The lack of affordable medical insurance was cited as a problem for the community by 72.5% of the respondents. Twenty percent (19.6%) of the respondents indicated this as an issue in their home. The ability to find a provider that accepts Medicaid was a problem or issue for 43.0% of the respondents. Medical insurance concerns were in the top ten concerns in 2001 and 2006 for both the community and home.
- Three mental health issues were rated as a concern within the respondents' communities. These included a lack of

suicide prevention services (44.5%), depression care and treatment services (44.2%) and stress and anxiety care and treatment (43.6%),

- There were community concerns about the lack of obesity or weight control education and treatment at 43.6%.
- In the schools and in the communities there was a concern about access to sex education and treatment for sexually transmitted diseases and infections (34.2%), suicide prevention services (44.5%), and teen pregnancy prevention programs (59.5%).
- Access to dental services (27.2%), medical specialists (38.0%), dementia and Alzheimer's disease care and treatment (41.0%), and primary care physicians (30.7%) were reported as community concerns by the respondents.

### **Requirements For Basic Needs of Shelter, Finance, and Transportation**

- Almost three-fourths of all households (72.0%) say that the lack of affordable housing is a problem for the community and 60.5% reported issues about substandard housing.
- Sixty percent (60.0%) reported concerns about the ability to pay utility bills, ability to manage credit cards, mortgage or rent (60.1%), and ability to save or invest money (60.4%). Budget and money management were concerns for 55.2% of the respondents.
- The lack of public transportation was seen as a community issue for 49.7% of the respondents. About 3% of the respondents

saw it as a home issue (2.7%).

- Over forty percent of the respondents (44.5%) reported that a lack of access to food was a community issue. Six percent of the respondents (5.6%) indicated that it was an issue in their home.

## **Child & Adolescent Needs**

- Child abuse and neglect was reported as a community concern by 66.6% of the respondents. About eight percent of the respondents reported this as an issue in the home (7.8%) and in the school (7.1%).
- Affordable youth activities in the community were cited as a needed service by 65.9% of respondents. The lack of positive youth activities were reported by 58.7% of the respondents.
- Family conflict and violence (62.6%) and domestic violence (70.2%) were two community issues linked to children and their families. Sixty percent (60.4%) of the using domestic violence services were satisfied with service received in the past six months.
- Internet safety was reported by 49.5% of the respondents as a problem within the community, while 19.0% indicated it was a problem in the schools. In 2006, internet safety was one of the top ten issues in the home.
- Bullying was the top issue reported for schools by 58.4% of the respondents. It was also the number one issue in 2006.
- Truancy and school dropout was a school concern for 46.4% of the

respondents. This was the number two issue in 2006.

- A concern about the level of literacy (reading and writing) of students was reported by 25.0% of the respondents. In 2006, it was 23.0% of the respondents who reported challenges in reading, writing, and mathematics as an issue within the schools.

## **Safety & Crime**

- Two thirds of the respondents (66.0%) reported vandalism as a problem for their community.
- Violent crimes (shootings, assault, fighting, etc.) were seen as problem within the respondent's community (47.0%). Over half of the respondents (57.5%) reported sex crimes (rape, indecent exposure, etc.) as an issue within their community.
- Over half of the respondents (57.4%) using restorative justice processes and mediation services were satisfied with the results. Less than ten percent (6.6%) of the respondents reported needing the services.
- Three-fourths of the respondents (76.1%) who used law enforcement services were satisfied with the services. One in five (19.3%) used the law enforcement services.



# **Black Hills Community Needs Assessment 2011**

## **Overview**

A consortium of local organizations in the Black Hills commissioned the South Dakota Public Policy Institute, a project of the Chiesman Center for Democracy, to conduct a Community Needs Assessment study in the Black Hills area. Areas included in this assessment are Butte County, Lawrence County, Meade County, Fall River County, Custer County and Pennington County. The consortium was composed of:

The purpose of the needs assessment study is to provide service organizations within the Black Hills communities with information about the gaps in services and the quality of the services being delivered. Additionally, the study gives the various providers information about the general effectiveness of their services and some insight into the procedures for addressing specific implementation strategies and delivery modalities. Some of the members of the coalition have a broad mandate to serve the whole Black Hills area, while some members are focused within a town or county. The data gathered from the study helps both types of providers by preserving their organization mandate or taking into consideration an expansion of needed services. Overall, the Black Hills Community Needs Assessment Study will help to

- (1) identify the services that are being used or not being used by residents in six Black

Hills counties;

- (2) establish the priority areas of greatest need for the community, home and school;
- (3) rate the quality of services being received; and
- (4) match the use of services with specific populations and resources.

The study will compare the findings from two previous community needs assessment to determine any positive or negative changes in addition to trends over the past 10 years. The evidence will be used to help organizations establish priorities and to develop political, educational, health or social changes to link the needs to areas requiring the greatest attention and response.

## Methodology

A team made up of members of all the contributing organizations, as well as the South Dakota Public Policy Institute staff, collaborated on the designed of a paper and web-based questionnaire for this study. The questionnaire was designed to be completed by randomly selected individuals 14 years of age or older. The questionnaire included 17 items on demographics; 67 items identifying areas of concern in the community, home, or school;. 40 items on areas of need, use of services, and the quality of services. There were three open ended questions for qualitative comments and feedback.

Over 33,012 questionnaires were mailed in December 2010 to a random sample of households in the six counties. A postcard was to sent to the selected households to inform them that they have been selected to complete a questionnaire and would welcome their participation in this endeavor. Postcard reminders were then sent after two weeks to thank everyone who had completed the questionnaire and to encourage non respondents to complete the questionnaires. The total mailing had a 10.9% response rate with the best response in Pennington County (12.3%) and the lowest rate in Fall River County at 7.7%. The margin of error for the total sample was calculated to be  $\pm 1.54\%$  with individual counties ranging from  $\pm 2.35\%$  to  $\pm 7.49\%$  (Table 1.0).

Throughout this study, comparisons are made to the 2001 and 2006 questionnaires. While these comparisons may be useful, it is important to understand the differences in the three studies.

- Survey methodology was different.
  - 2001 survey was conducted by telephone.
  - 2006 survey was conducted by mail with responses returned by mail.
  - 2011 survey was conducted by mail with responses returned by mail or completed on the web site.

- Geographic area was different.
  - ◆ 2001 sample was composed of 50% Rapid City, 25% Sturgis, and 25% Lawrence County.
  - ◆ 2006 sample was composed of 26% Pennington County, 21% Meade County, 30% Lawrence County, and 23% Butte County.
  - ◆ 2011 sample was composed of 38% Pennington County, 20% Meade County, 22% Lawrence County, 8% Butte County, 6% Custer County, and 6% Fall River County

- Questionnaire was different.
  - ◆ 2001 questionnaire asked whether an issue was “not an issue, a minor issue, a moderate issue, or a major issue for people in *your neighborhood*” or “has any one of the following been an issue for you or anyone *in your household over the past 12 months.*”
  - ◆ 2006 and 2011 questionnaires asked respondents to check if an item is a problem in their community, home, or school.
  - ◆ There are differences in wording between similar issues on the 2001, 2006, and 2011 surveys.
  - ◆ Some issues included in the 2001 survey were not included on the 2006 and 2011 questionnaires. The 2011 questionnaire added and expanded on many of areas with more questions on health, art, and social services.

# Findings

## Ranking of Needs

The findings are present as the whole Black Hills, by county, and by sectors. The sectors include work and employment, education, safety and crime, child and adolescent issues, health issues, housing, art and culture, and general issues. The top ten issues for the whole Black Hills (Table 2.0) is divided from the community, home and school perspectives. For example, the top issue identified for the community was the lack of good paying jobs (91.3%) while for the home it was the ability to save or invest money (22.7%). The top issue for schools was bullying (58.4%) while 78.3% report that youth prostitution was not an issue in the Black Hills.

Table 3.0 shows the top ten community or neighborhood issues by year. The top issue for all three years of the community needs assessment was the lack of good paying jobs. In 2011, 91.3% of the respondents indicated this was the top community concern, while in 2001 only 62% reported it as a concern. Vandalism, unemployment, domestic violence, child abuse and neglect were issues not included in the previous studies.

Table 4.0 shows the top ten household issues by year. Top issue for each year was different, but they still remain in the top ten. In 2011, domestic violence, lack of recycling programs, family conflict and violence were not included in the previous studies. Home issues continue to focus on health, finance, and safety issues.

Table 5.0 shows the top ten school issues for 2006 and 2011. Both studies show that bullying and truancy are the top issues. The percentages for each of the top issues are higher than the 2006 student. This is attribute to the higher percentage of parents and guardians responding to these items.

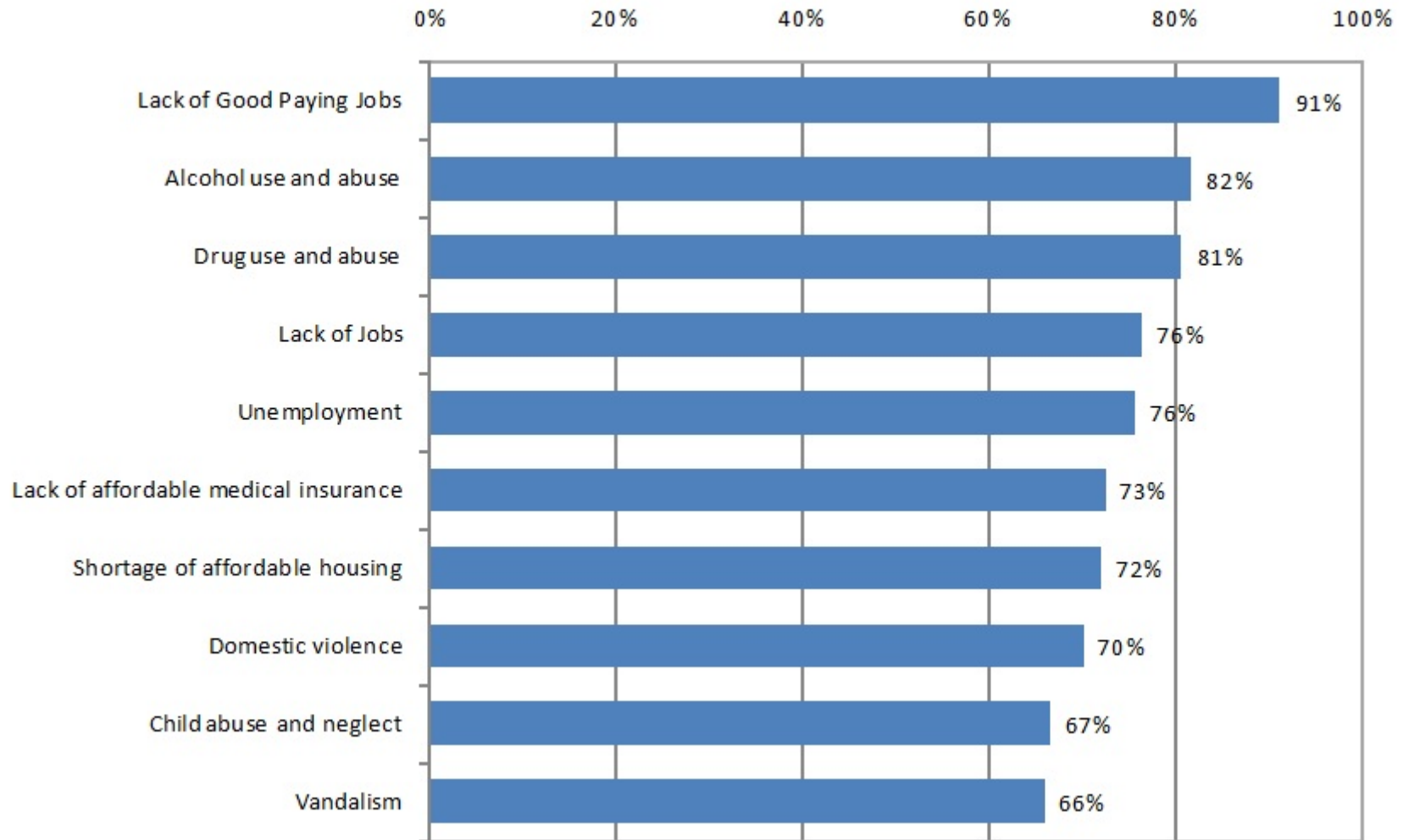

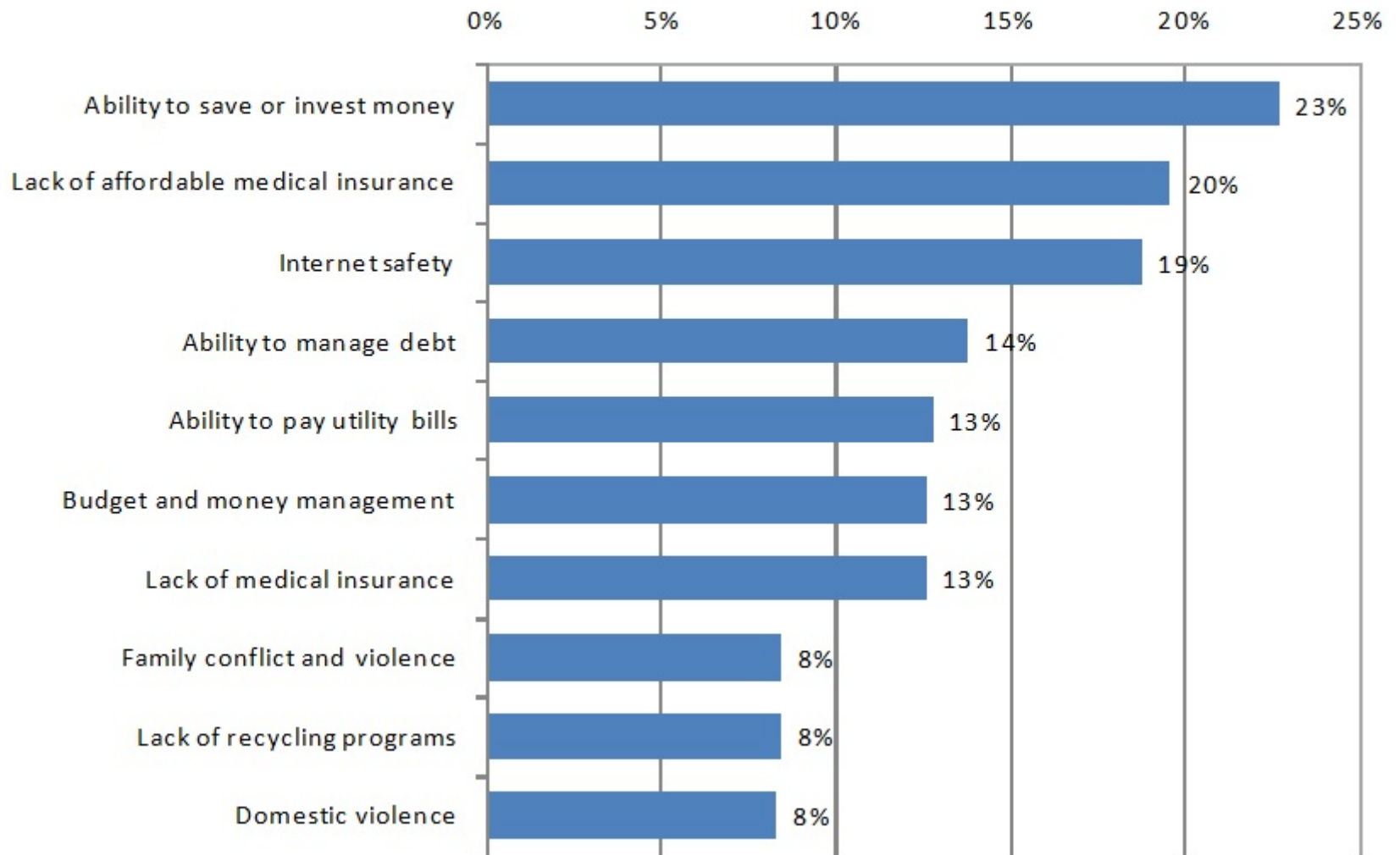

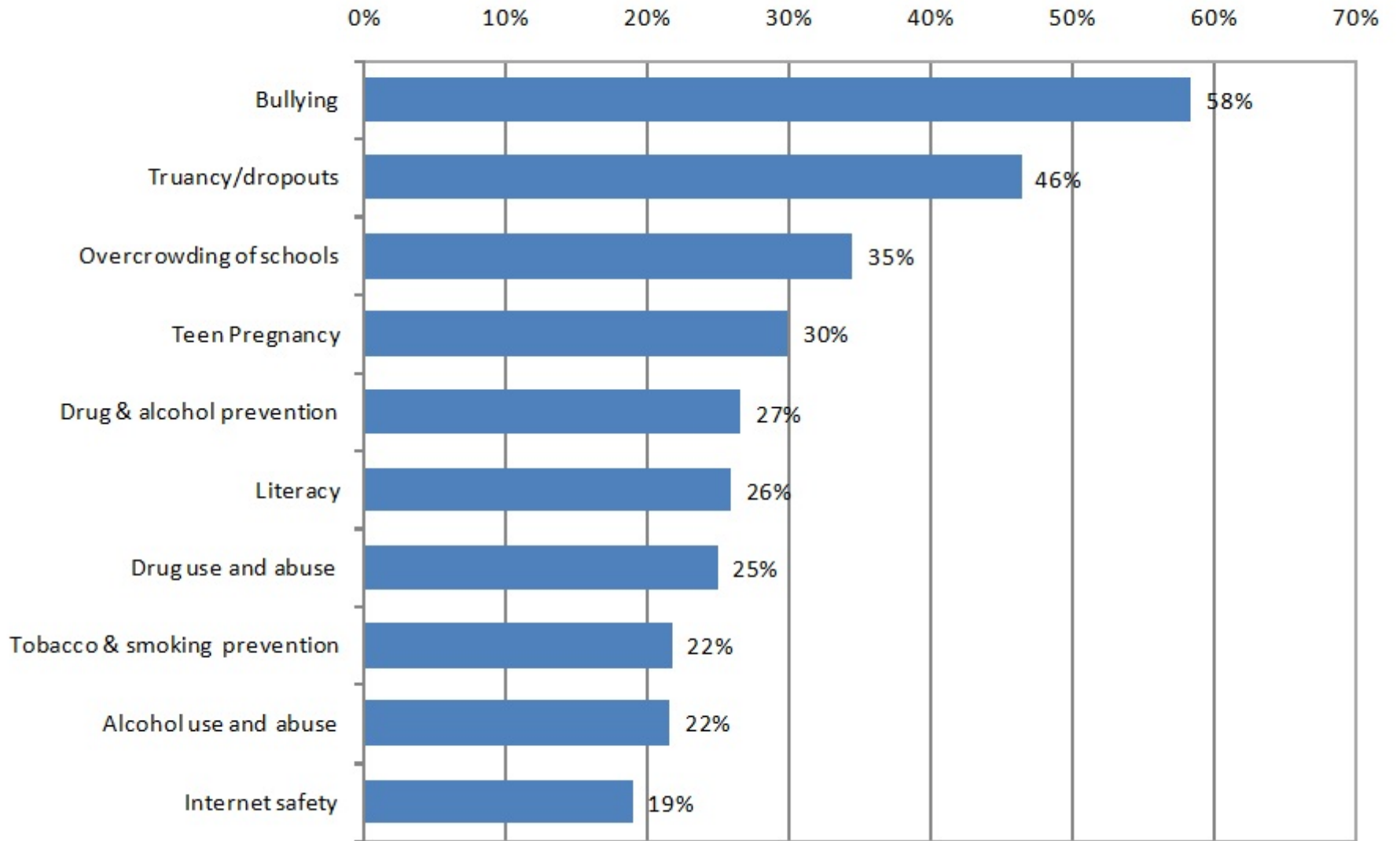
## Top Ten Household Issues

## Services Needed

Table 6.0 shows that dental services were services needed by the respondents, 46.7% in 2006 and 34.3% in 2011. Medical insurance was the next most needed service for both years, 43.5% in 2006 and 33.2% in 2011. Support for pay utility bills (18.2% in 2006 and 13.7% in 2001) and public transportation (17.3% in 2006 to 11.9% in 2011) appear on both rankings. The remainder of the top ten differ in the needs.

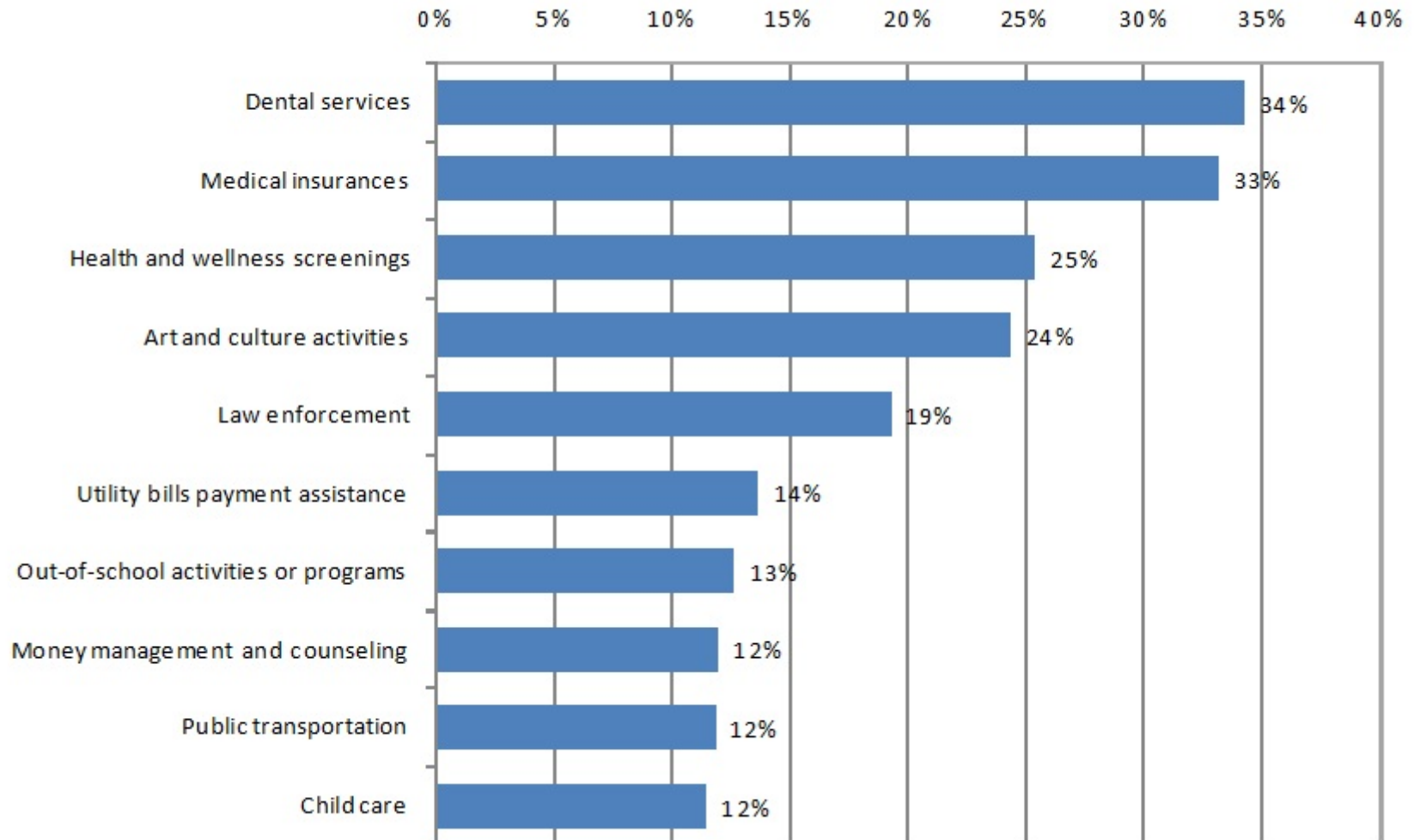
When matching community needs (Table 3.0) with needed services (Table 7.0) only medical insurance appear on both tables. One interpretation for this lack of connection maybe due to the fact that a service or program may already exist in the community, but the issue is still prevalent and still requires attention. In identifying service needs, the respondents were explicit about not having these services or programs available in their community or how to access them. If a person matches Table 6.0 with Table 3.0, then ineffectiveness of services and programs are linked. Unsatisfactory rates are noted in dealing with the community, home and school issues of domestic violence, truancy prevention, teen pregnancy prevention, drug and alcohol prevention services, and job training opportunities

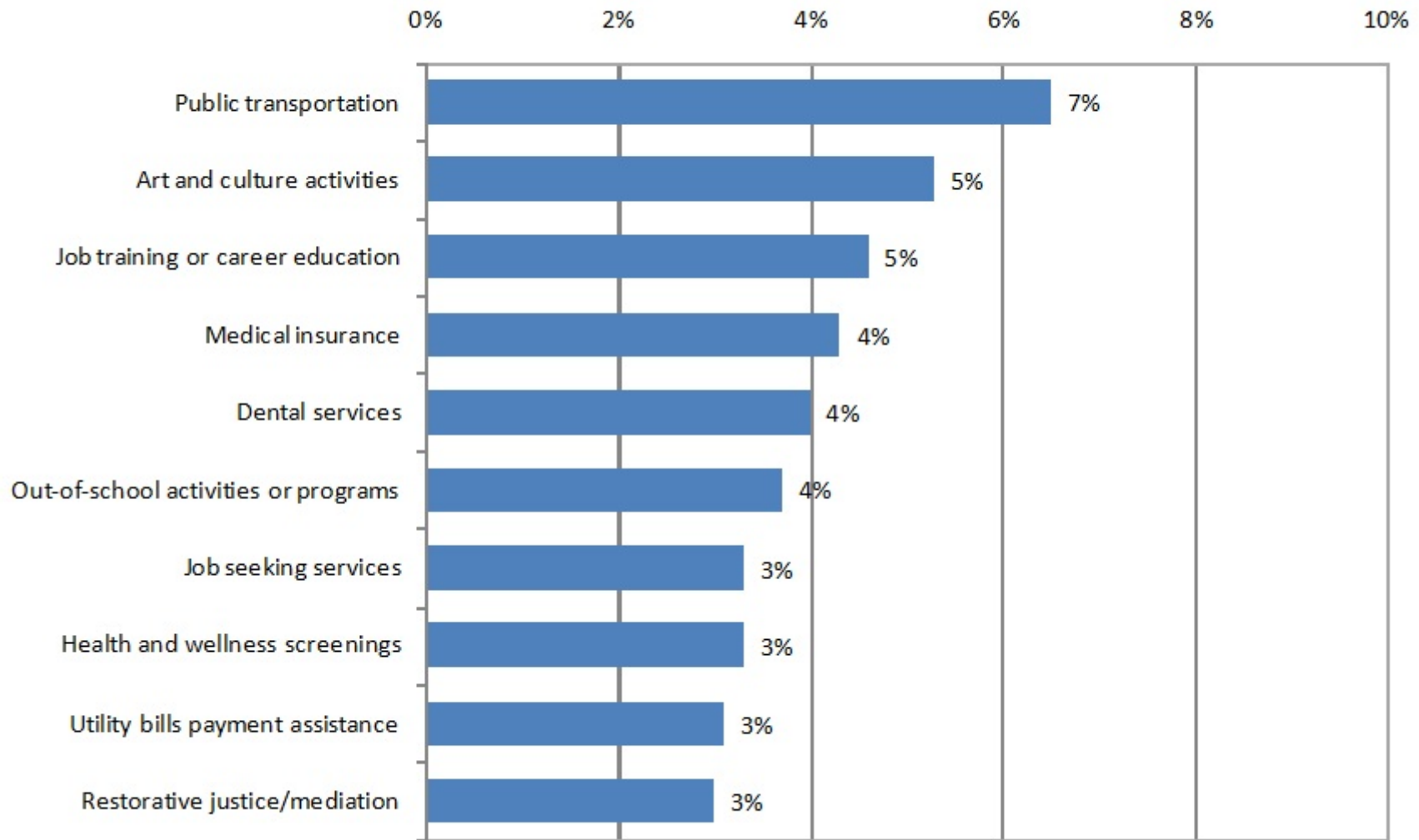

## Employment Needs

A lack of good paying jobs is viewed as the community's biggest problem with agreement by 91.3% of the respondents (Table 8.0). Three-fourths of the respondents (76.4%) of respondents indicated that there was a lack of jobs in their community, while 75.7% indicated that there was an unemployment issue in their community. When the issues were personalized to the home, 7.5% of the respondents indicated that the lack of good paying jobs was an issue in their home. Four percent (3.9) indicated there were no jobs available for them and thus contributed to a 4.4% unemployment rate in the home. One in four respondents indicated that unemployment and lack of jobs was not an issue in their community. Two-thirds of the respondents (62.8%) indicated that job training opportunities were lacking in the community.

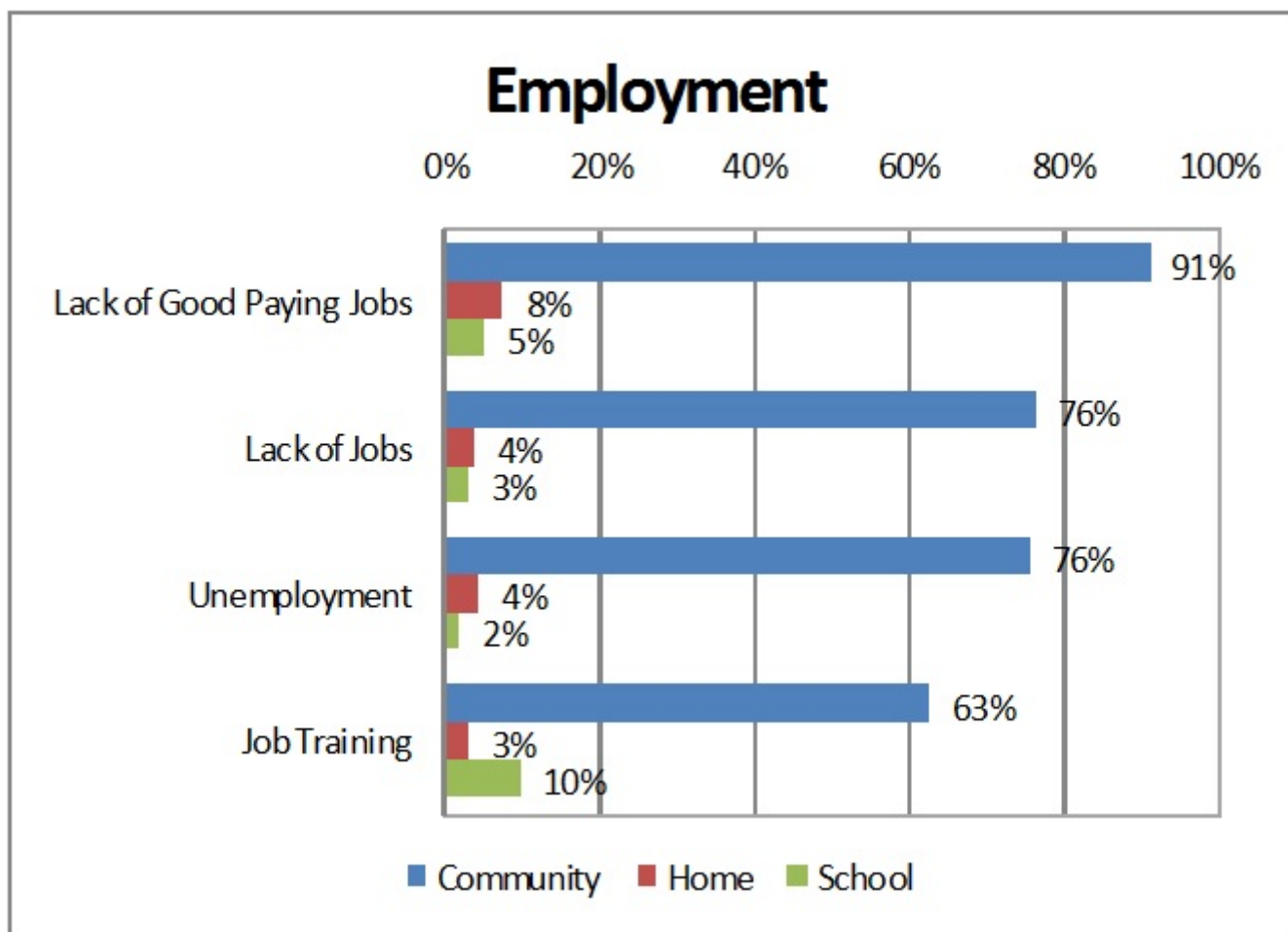

Thirteen percent (12.6%) of the respondents reported that there was a need for job seeking services. This was evident in the rural areas, where employment services were not readily available. Additionally, 14.3% indicated a need for job training or career education opportunities. For individuals not living in Spearfish, Rapid City or their contiguous locations, training and education becomes an issue if adequate transportation or distance is a problem.

Table 8.2 shows the rate of unsatisfactory services for individuals seeking a job at 36.5% of the respondents using the service (n = 345 or 9.9% of the all the respondents). Two out of five respondents (41.5%) using the job training services were unsatisfied with the services received.



## Education Issues

The highest area of educational concerns was in the areas of prevention. Over half of the respondents (54.3%) report a concern for a lack of an effective drug and alcohol program within their community. This was followed by the tobacco and smoking programs at 47.0% of the respondents. Literacy (45.4%), truancy and dropout rates (41.3%), and bullying (40.0%) were also identified as troubling for the community. From the school perspective bullying (58.4%) was the highest issue, while truancy and student dropout was rated the second highest concern at 46.4%.

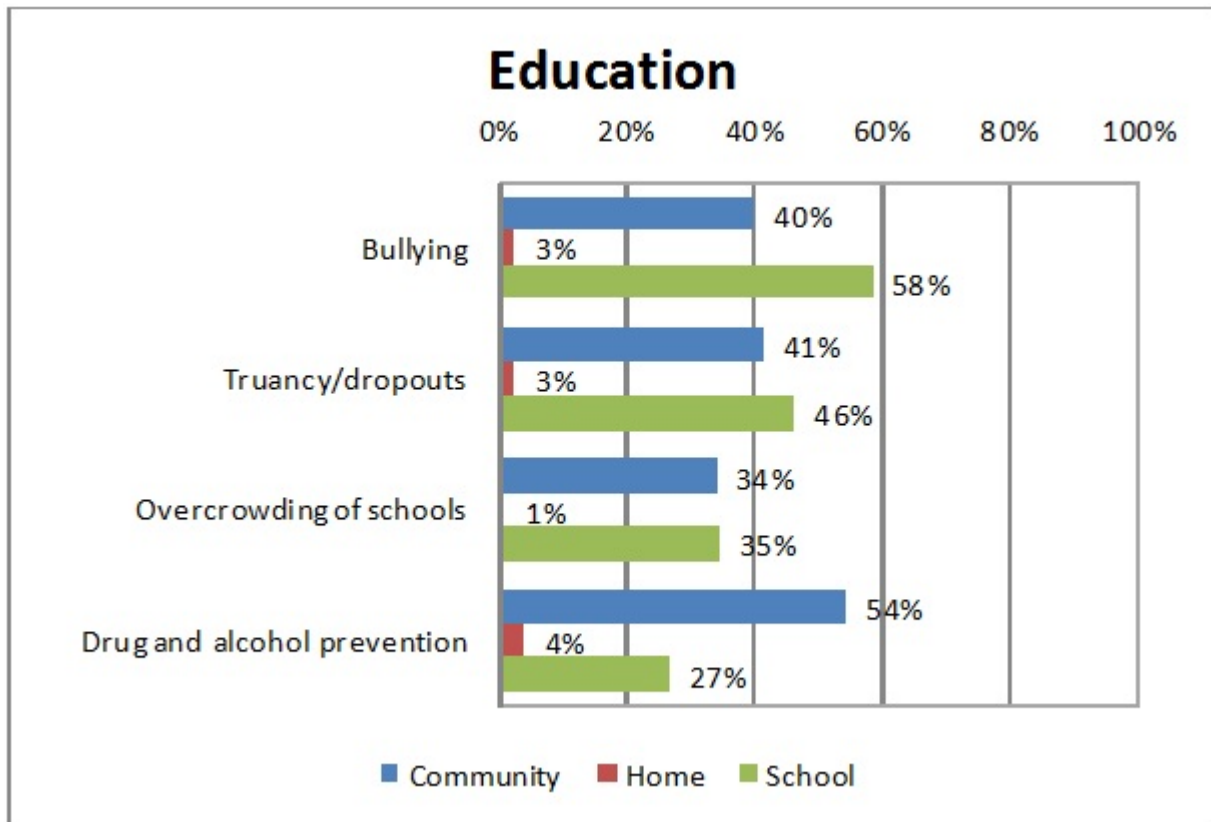

About sixteen percent (16.3%) of the respondents reported a need for more out-of-school activities within their communities. The next highest need was in the area of drug and alcohol prevention (9.7%). This was followed by the drug and alcohol prevention programs within the community at 39.6%.

For individuals who had used the program, 44.8% of the users were unsatisfied with the truancy and dropout prevention programs.



## Crime & Safety Issues

The highest area of crime and safety concerns was in the areas of substance use and abuse. Four in five of the respondents (81.7% and 80.7%) reported a concern for issues linked to drug and alcohol use and abuse within their respective communities. The substance use and abuse issues were the highest at the school level at 25.0% for drug use and 21.6% for alcohol use. The next highest area of community concern was domestic violence at a rate of 70.2%. While for the home and the school it was internet safety at 18.8% and 19.0%. Internet safety was the highest concern in the home, while in the school it was the third highest concern. Three in four respondents (78.3%) did not find youth prostitution as a problem in the community.

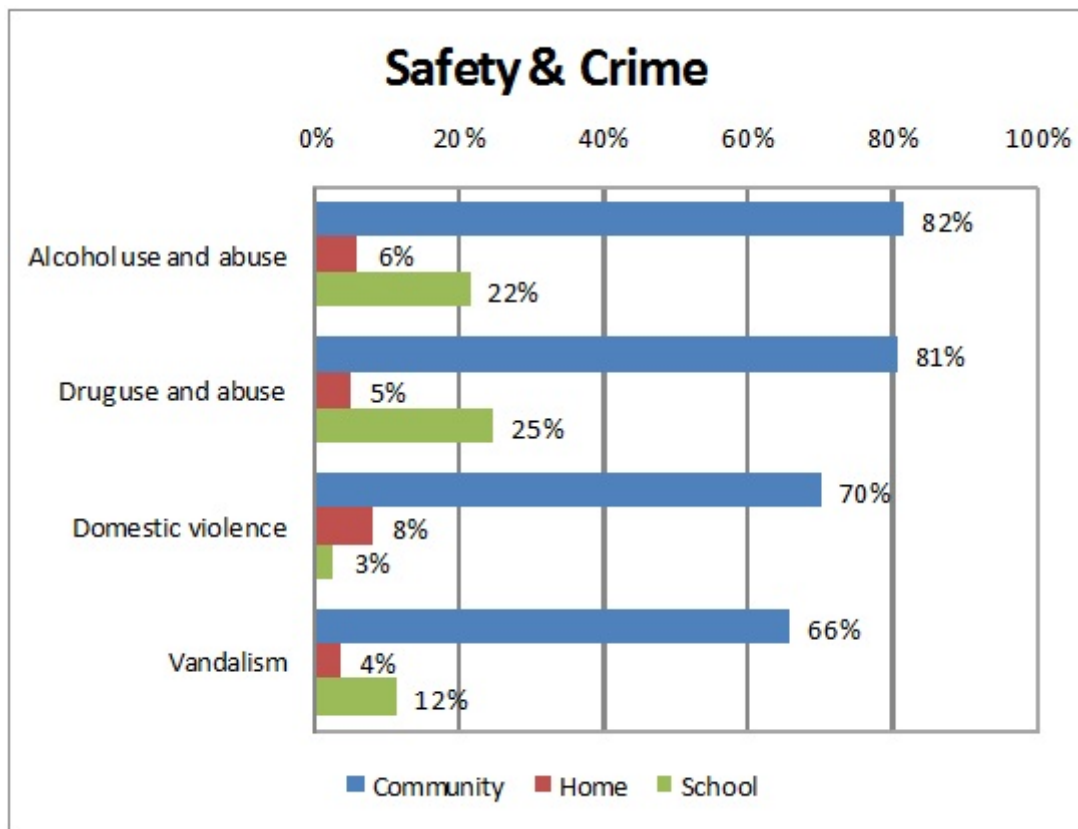
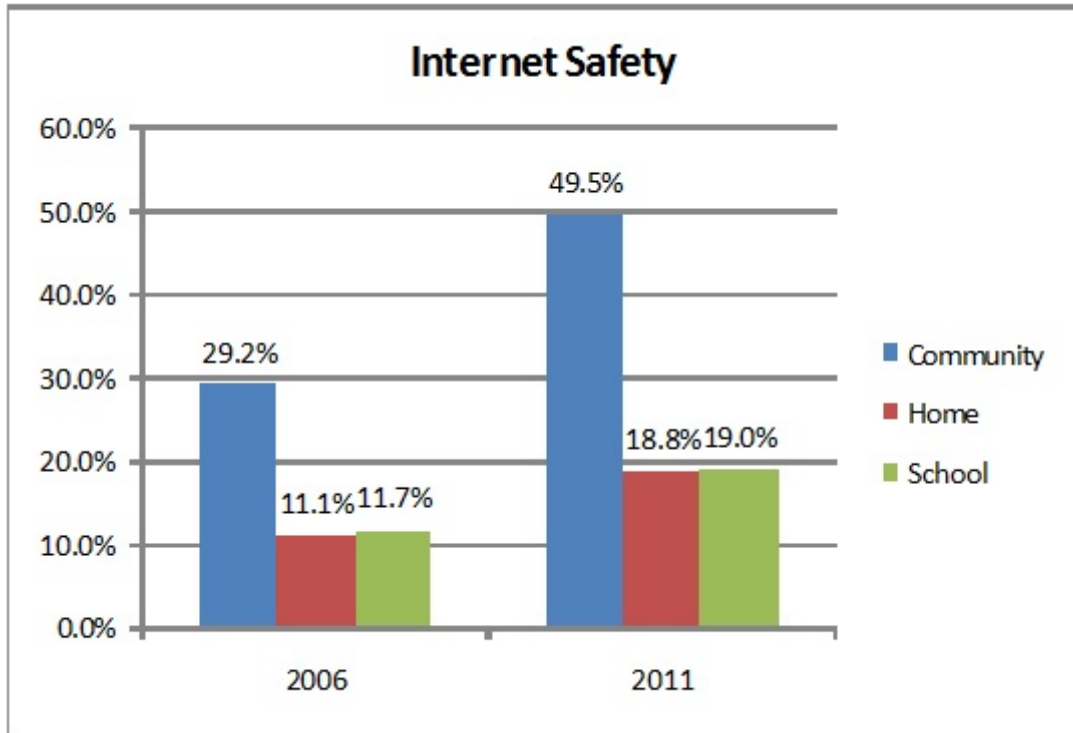

About 20% of the respondents (19.3%) reported the use of law enforcement, with 76.1% being satisfied with the service received. Eight percent of the respondents (8.2%) reported using service related to domestic violence with 60.4% of respondents satisfied with the services and assistance received. Seven percent of the respondents (6.6%) reported using restorative justice processes and mediation services. Over half of the users (57.4%) were satisfied with the services they received.

## Child and Adolescent Issues

The highest area of concern for child and adolescent issues was in the area child abuse and neglect. Two thirds of the respondents (66.6%) reported a concern for this issue in their respective communities. The lack of affordable child care (64.8%), lack of affordable youth activities (65.9%) and family violence (62.6%) the next three highest areas of concern within the community. For the home family conflict and violence (8.4%) was the highest concern followed by child abuse and neglect (7.8%). In the school teen pregnancy was the highest rated area of concern (29.9%) with lack of positive youth activities being the second highest area of concern (18.3%). Half of the respondents did not find a lack of neighborhood childcare (52.5%) and homeless or runaway youth (50.9%) a problem within their respective communities.

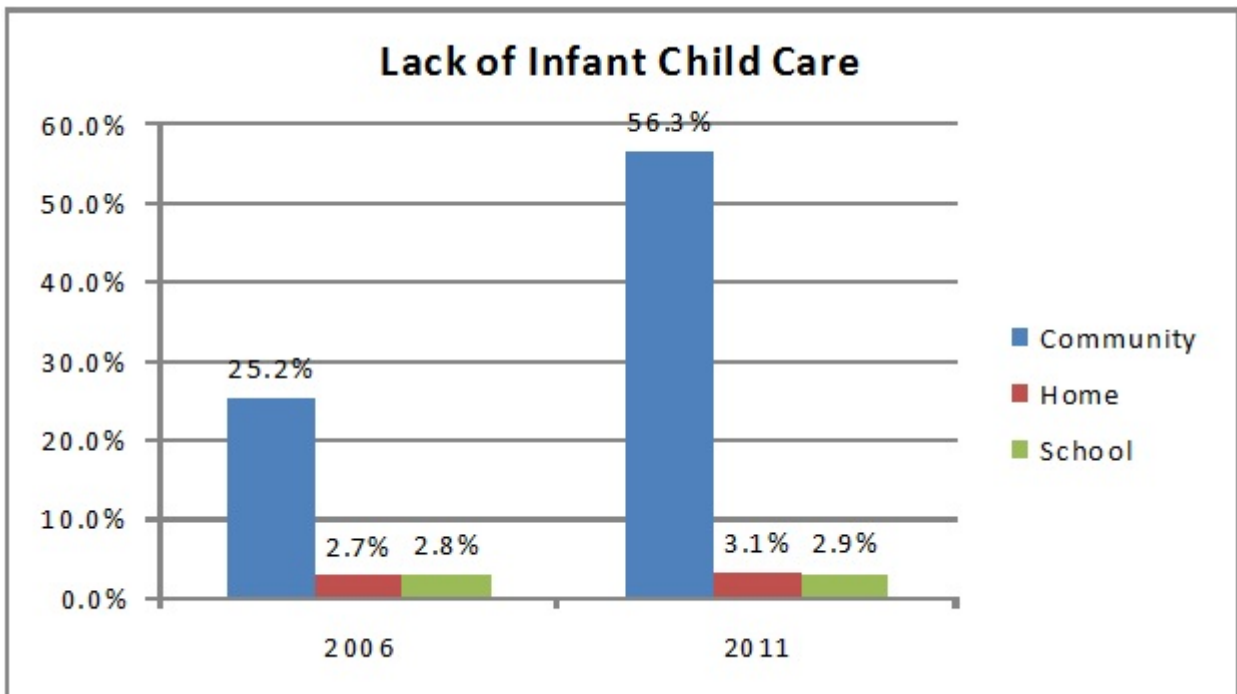
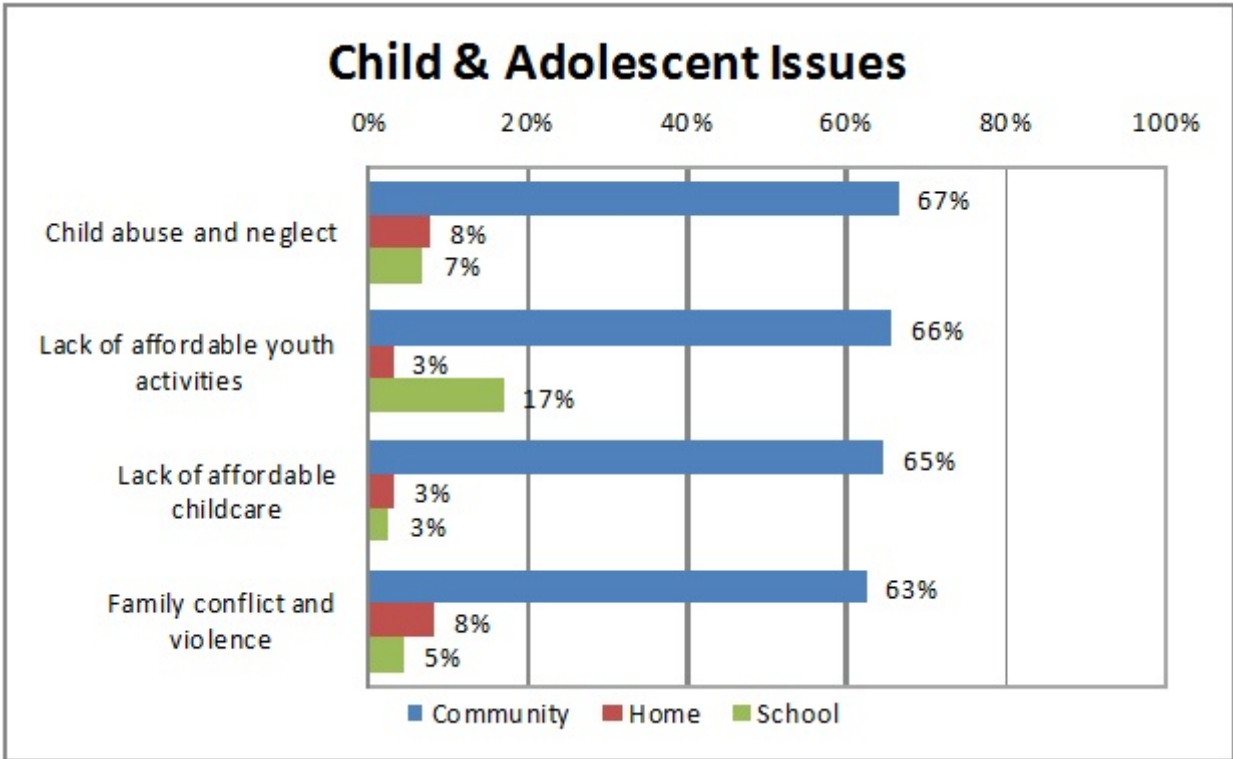

One in ten respondents needed child care services (11.4%) and 80.2% were satisfied with the services they received. Nine percent (8.9%) reported using special needs services for their child(ren) with 71.9% reporting that they were satisfied with the services received.



## General Issues

Gambling and the lack of recycling programs were rated the highest community concern by the respondents at 62.7% and 60.4% respectively. The next areas of concern were connected to financial issues. They included the ability to pay utility bills (60.0%), ability to manage credit cards, mortgage or rent (60.1%), and the ability to save or invest (60.4%). The top issue in the home was the ability to save or invest money (22.7%) followed by ability to manage credit cards and money (14.5% and 12.6% respectively). In the school 14.5% reported that there was a lack of programming to address independent living skills.

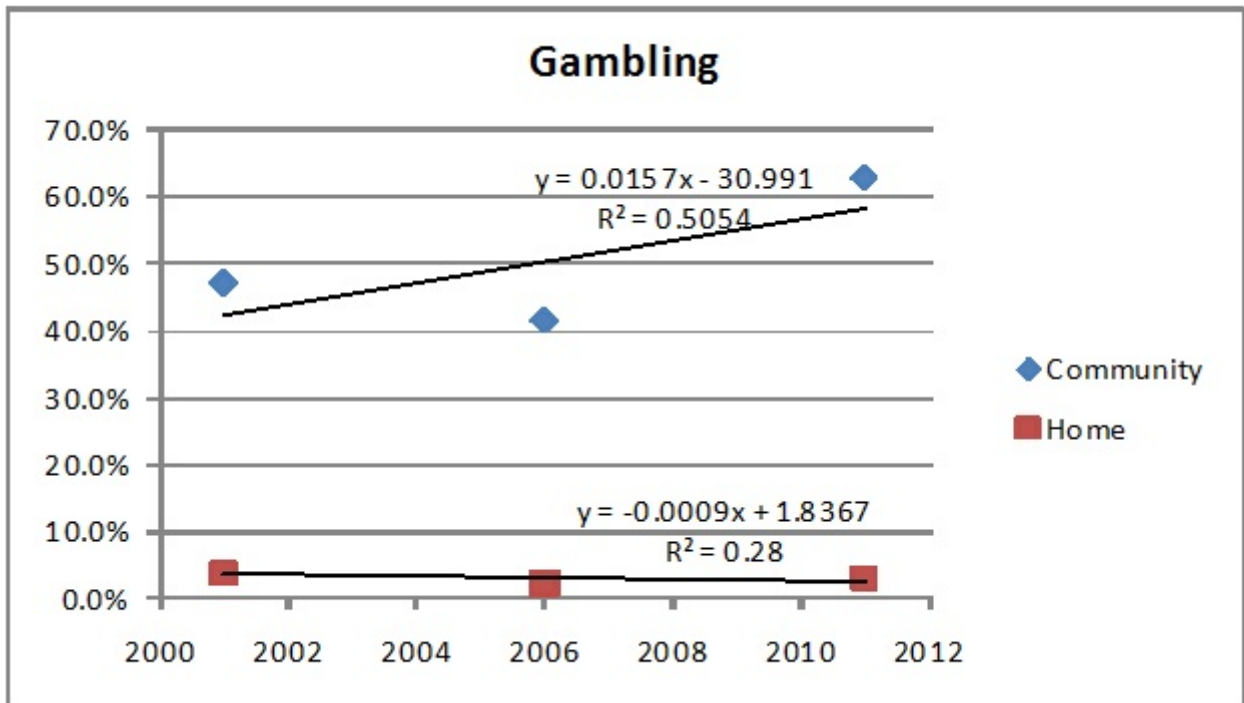
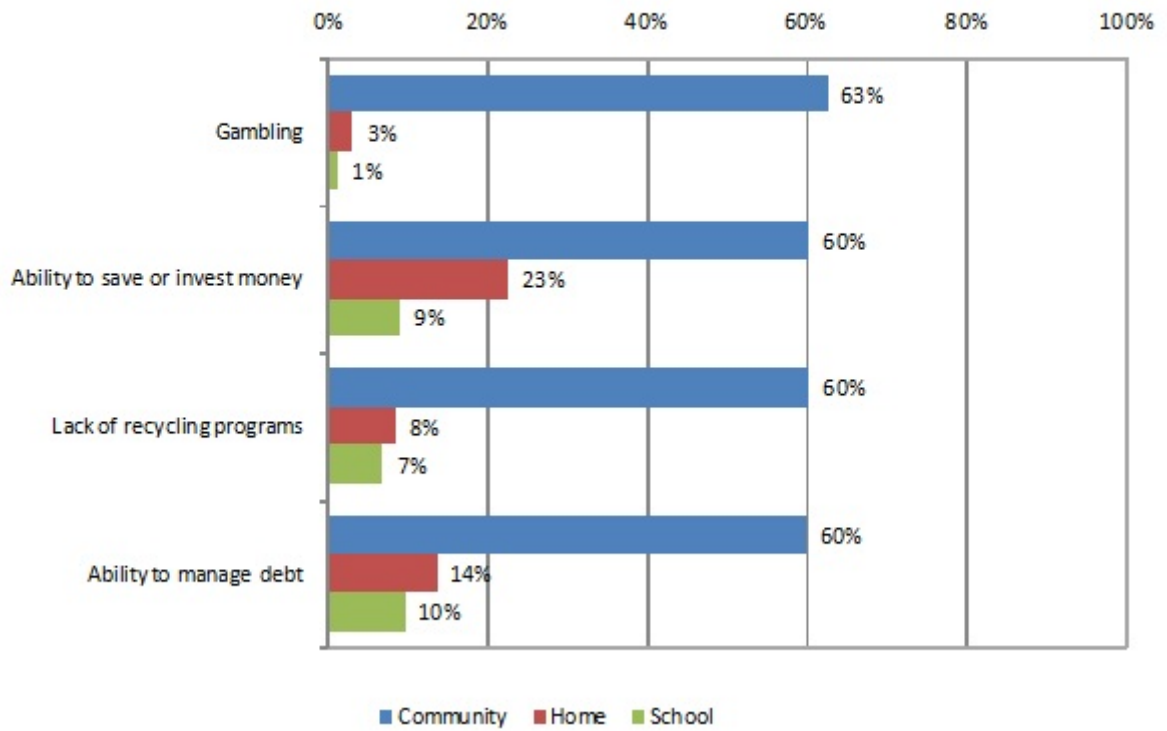

## General Issues



## Medical, Mental & Dental Health Issues

The top community and home concerns regarding health issues were related to medical insurance. Three-fourths of the respondents (72.5% ± 1.5%) indicated that lack of affordable medical insurance was a community issue and 19.6% of the respondents indicated it a home issue for them. Having no medical insurance was the second concern by 63.4% of the respondents. It was also the second highest concern in the home at 12.6%. Over forty percent (43.0%) indicated that ability to find a provider who accepts Medicaid was a major issue.

When asked about having access to various mental health services and treatments, there were four top community concerns. These included suicide prevention services (44.5%), depression care and treatment (44.2%), stress and anxiety care and treatment (43.6%), and obesity or weight control education and treatment (43.6%).

There were five health access concerns for the home. Three of the areas were similar to the community concerns. These included obesity or weight control education and treatment (7.2%), dental services (6.7%), stress and anxiety care and treatment (5.9%), depression care and treatment (5.3%). For the school there was concern about access to sexually transmitted diseases and infections education and treatment (16.3%), suicide prevention education (14.0%), and obesity or weight control education (12.5%).

The respondents reported that they did not have a problem accessing prenatal care (73.1%), pediatric care (72.0%), and heart care and treatment (70.0%). But there was concern about access to other medical specialists (38.0%), primary care physicians (30.7%), and dental services (27.2%).

Respondents reported a concern about access to pre-diabetes and diabetes education and treatment (30.4%), dementia or Alzheimer's disease care and treatment (41.0%), cancer care and treatment (31.8%), and arthritis, bone or joint care and treatment (30.4%).

When identifying areas lacking in service for the respondents, dental service was rated the highest at 34.1%. This was followed by medical insurance (33.0%) and health and wellness screening (25.4%). Four percent of the respondents indicated they needed these services but were not available in the location (Table 13.1).

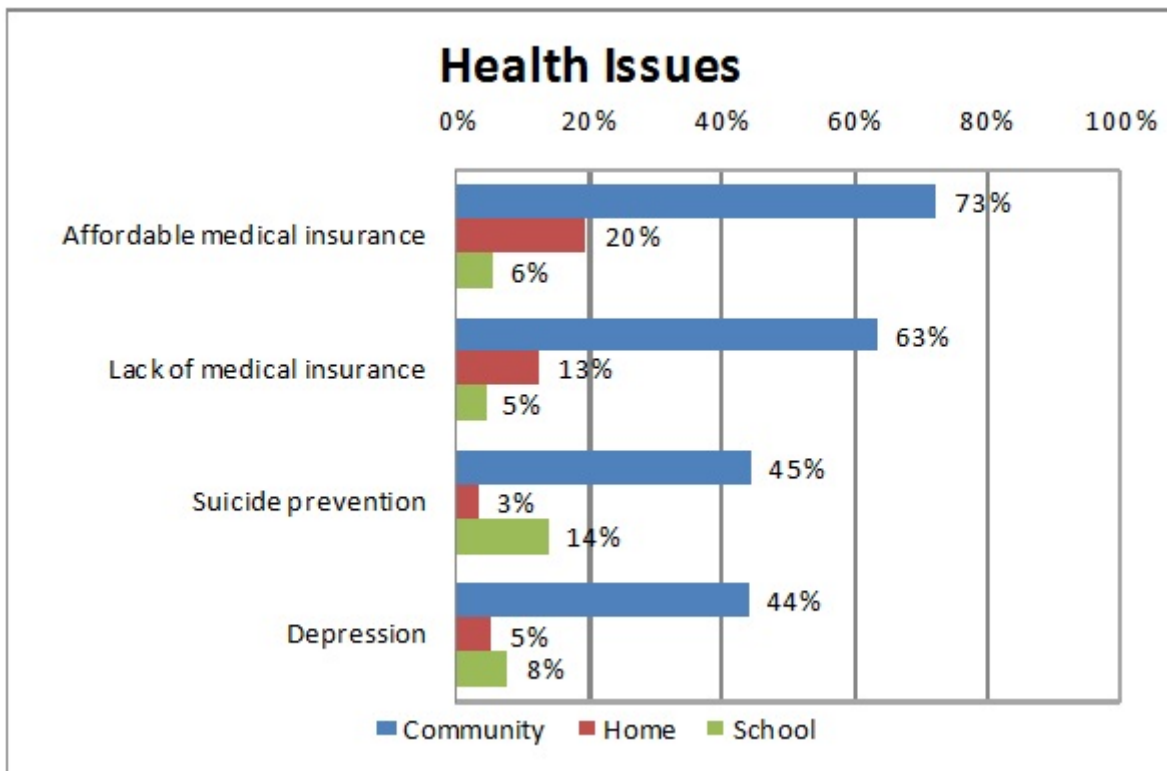

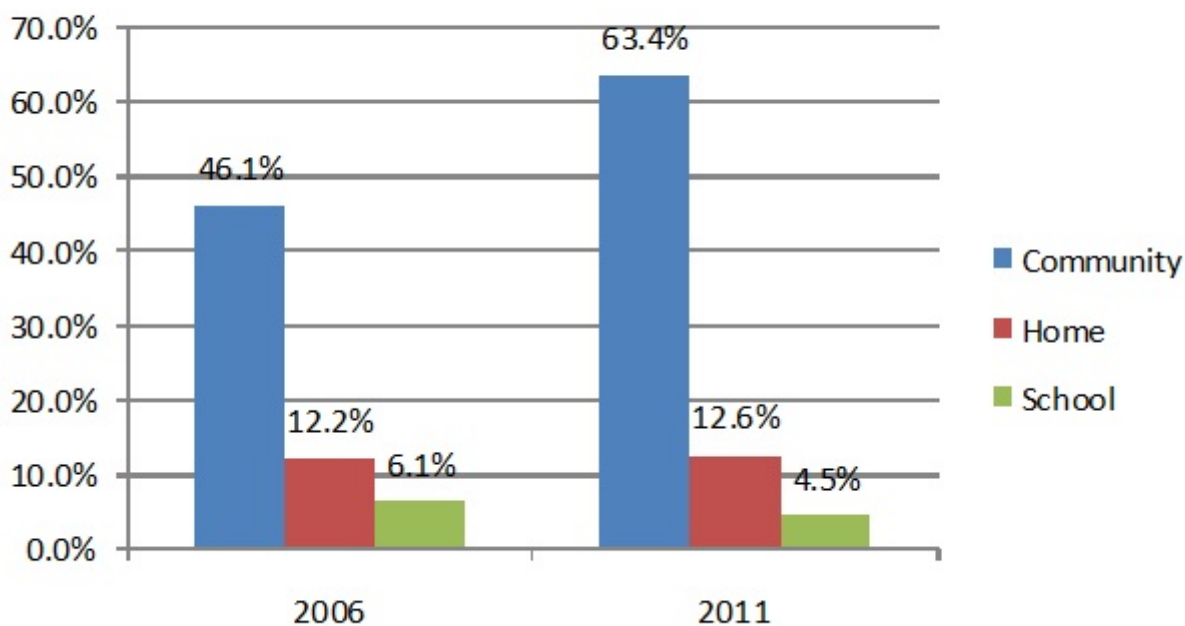

Table 13.2 shows that respondents (91.2%) were satisfied with the dental services they have received in the past six months. Almost 90% of the respondents (88.6%) reported that they were satisfied with the services focusing on health and wellness screenings. The areas with the largest dissatisfaction levels dealt with drug and alcohol treatment services (37.3%), depression and suicide services (32.5%), and suicide prevention services (42.5%). Some of the comments about the dissatisfaction with services was based on the local availability of professional and competent help. There were many comments that indicated that they had to travel to Rapid City in order to get any “good” services.

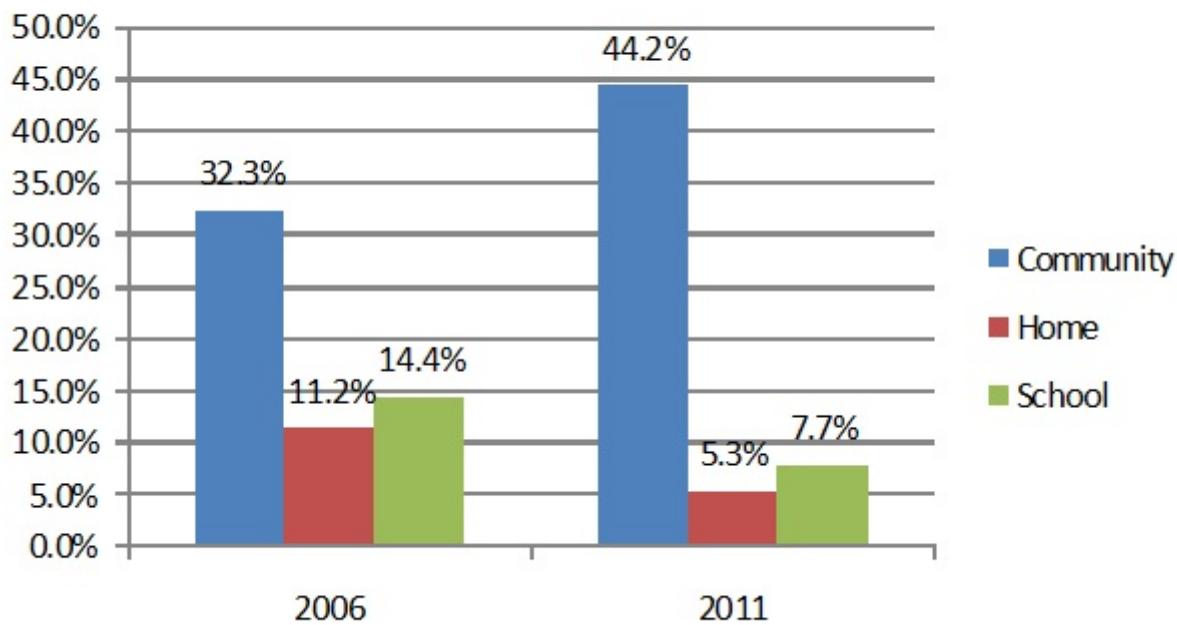
